



STIHL Australia – STIHL 100 Years Competition

1 Background

- 1.1 Information on how to enter this STIHL 100 Years Competition (**Promotion**) and prize details form part of these terms and conditions (**Conditions**).
- 1.2 The promoter is STIHL Pty Ltd trading as STIHL Australia, of 5 Kingston Park Court, Knoxfield VIC 3180, ABN 76 004 881 145 Telephone: (03) 9215 6666 (**Promoter**).
- 1.3 The Promotion is a game of chance and skill plays no part in determining winners. Each Entry will have an equal chance of winning. Participation in the Promotion is free of charge.
- 1.4 The Promotion will have up to eleven (11) winners, comprised of:
 - (1) one (1) major prize winner (**Major Prize Winner**) who will receive one (1) single-use discount code which is only redeemable via, and usable at, shop.stihl.com.au (**Online Shop**) by the Major Prize Winner to apply a \$2,000 discount to the total price of a single transaction for STIHL products on the Online Shop (**Major Prize**); and
 - (2) ten (10) secondary prize winners (**Secondary Prize Winner**) who will each receive one (1) single-use discount code which is only redeemable via, and usable at, the Online Shop by the Secondary Prize Winner to apply a \$500 discount to the total price of a single transaction for STIHL products on the Online Shop (**Secondary Prize**).
- 1.5 Each discount code referred to in clause 1.4 will be valid for a period of 6 months from its date of issue (**Validity Period**). For the avoidance of doubt, the discount codes referred to in clause 1.4 can only be used once each and must be redeemed in a single transaction on the Online Shop. The total price of the single transaction must exceed the value of the discount code in order for the prize winner to be able to apply the discount code.
- 1.6 Entries must comply with these Conditions to be valid.
- 1.7 By submitting an Entry and otherwise participating in the Promotion, Entrants acknowledge that they have read and understood these Conditions, and they agree to be bound by these Conditions.

2 Promotion Period

- 2.1 The Promotion commences on Monday, 8 June 2026 at 12.00pm AEST and closes on Friday, 31 July 2026 at 12:00pm AEST (**Promotion Period**). Entries received outside the Promotion Period will not be valid.
- 2.2 The draw process, including any further redraws, will occur after the end of the Promotion Period, as set out in clause 5.

3 Eligibility

- 3.1 Entry is open to all individuals who are:
 - (1) residents of Australia;

- (2) aged 18 years or older at the commencement of the Promotion Period; and
 - (3) if their Entry is selected, willing and able to redeem their prize via the Online Shop, at the time of entry into the Promotion (**Entrants**).
- 3.2 Directors, officers, employees, agents and contractors of the Promoter, authorised STIHL dealers and other agencies or companies associated with the Promotion (including employees of retailers participating in the Promotion) and their immediate families are not eligible to enter this Promotion. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or stepchild (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
- 3.3 For the avoidance of doubt, authorised STIHL dealers and their directors, officers, employees, agents, contractors and immediate families may not enter into the Promotion.
- 3.4 The Promoter reserves the right to verify the eligibility of any Entrant and their compliance with these Conditions. The Promoter may require such information as it considers reasonably necessary for this purpose.

4 Entry into the Promotion

- 4.1 To enter the Promotion, Entrants must complete and submit the user registration form at <https://www.stihl.com.au/en/stihl-100-years-competition> during the Promotion Period, upon which:
- (1) one (1) entry into the Promotion (**Entry**) will be registered for the Entrant; and
 - (2) the Entrant will be subscribed to the STIHL newsletter (if not already subscribed).
- 4.2 Only one (1) Entry per Entrant is permitted and will be valid.
- 4.3 The Promoter may, in its absolute discretion, deem any Entry invalid and disqualify the Entrant if the Promoter reasonably believes that:
- (1) the Entrant has not complied with any of the eligibility requirements set out in clause 3.1, or has otherwise attempted to circumvent those requirements or any other requirements set out in these Conditions, including (but not limited to) by using alternate identities, multiple email addresses, or different devices;
 - (2) the Entry is illegitimate, forged, AI-generated, manipulated or has been tampered with in any way;
 - (3) the Entry contains false, misleading, incomplete or inaccurate information, or was submitted for, or on behalf of, a person other than the person whose details were provided with the Entry; or
 - (4) the Entrant has engaged in any conduct that the Promoter considers, in its sole discretion, to be fraudulent, misleading, deceptive, bad faith, or otherwise designed or intended to interfere with the fair and proper conduct of the Promotion.
- 4.4 Incomplete, indecipherable, or illegible Entries, or Entries that do not comply with these Conditions, will be deemed invalid.
- 4.5 Entrants will be disqualified and their Entry deemed invalid if, prior to the end of the Promotion, the Entrant unsubscribes from the STIHL newsletter.

- 4.6 The Promoter accepts no responsibility for any misdirected or lost Entries or Entries not received within the Promotion Period specified in clause 2.1.

5 Winner Selection, Notification and Verification

- 5.1 The draw to determine the one (1) Major Prize Winner and the ten (10) Secondary Prize Winners of the Promotion will take place at 5 Kingston Park Court, Knoxfield VIC 3180 on Monday, 17 August 2026 at 3:00pm AEST (**Draw**).
- 5.2 The Draw will be conducted by random electronic selection from all valid and eligible Entries received by the Promoter during the Promotion Period. The Major Prize Winner will be drawn first in the Draw and, once the Major Prize Winner has been determined, the Secondary Prize Winners will be simultaneously drawn second in the Draw. Each Entry drawn will be validated by the Promoter for compliance with these Conditions. Entries that do not comply with these Conditions in any respect will be invalidated and redrawn.
- 5.3 The results of the Promotion will be published by the Promoter as follows:
- (1) the first name initial, surname and postcode of residence of the Major Prize Winner and Secondary Prize Winners will be published on www.stihl.com.au within approximately 24 hours of the Draw; and
 - (2) the first name, surname, and postcode of residence of the Major Prize Winner will be published in a local or national newspaper within 7 days of the Draw, or such other reasonable timeframe as determined by the Promoter.
- 5.4 All Entrants will be notified by email from the Promoter that the Draw has been conducted and that the Major Prize Winner and Secondary Prize Winners have been selected within approximately 24 hours of the Draw. Each winner will also be notified directly in writing via email from the Promoter within approximately 24 hours of the Draw with details of their prize and with directions on how they may claim their prize (**Directions**).
- 5.5 Subject to winners claiming their prize in accordance with the Directions, the Promoter will deliver the relevant prize to each winner within 28 days of the winners being announced, subject to any processing or delivery delays which will be notified to winners.
- 5.6 If a winner cannot be contacted or does not claim their prize within 3 months, despite reasonable efforts by the Promoter, or the winner is not eligible for the prize or has not complied with the Conditions, then the Promoter may withdraw the prize from that winner and award that prize to a replacement winner selected by a further draw conducted by random electronic selection from:
- (1) in the event that the Major Prize is not claimed—from all valid and eligible Entries of the Secondary Prize Winners received by the Promoter during the Promotion Period (in which case the selected Secondary Prize Winner will become the Major Prize Winner and their Secondary Prize will be redrawn pursuant to clause 5.6(2) below); and
 - (2) in the event that a Secondary Prize is not claimed—from all valid and eligible Entries received by the Promoter during the Promotion Period,
- (**Redraw**).
- 5.7 Any Redraw required under clause 5.6 will be conducted at the same location and using the same method as the Draw, the results of any Redraw will be published in the same manner as the Draw, and the winners of any Redraw will be notified in the same manner as the original winners of the Draw.

- 5.8 The Promoter reserves the right to at any time verify the eligibility of any Entrants, the validity of any and all Entries, and the compliance of any Entrant with these Conditions. The Promoter may require such information as it considers reasonably necessary for this purpose and reserves the right to disqualify any Entrant if it reasonably suspects the Entrant has: (a) provided false or misleading registration information; (b) tampered with the entry process; or (c) engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion.

6 Prize Details

- 6.1 The prizes for the Promotion are as set out in clause 1.4.
- 6.2 The eligibility of an Entrant to receive one of the prizes in the Promotion is conditional on the Entry requirements in clause 4 being satisfied. No Entrant is eligible to receive more than one prize.
- 6.3 Each prize is not transferrable or exchangeable, cannot be taken as (or exchanged for) cash, and is only redeemable via, and usable on, the Online Shop. The availability of products on the Online Shop may vary and is subject to change and stock.
- 6.4 If the prize becomes unavailable for any reason the Promoter may substitute it with an alternative prize of equal or greater value to the extent permitted by applicable laws.
- 6.5 Each prize must be taken as described and no compensation or other amounts will be payable if the winner is unable to use the prize (including if the prize expires without being used by the winner for any reason). Any costs incurred in connection with taking or using the prize (including any tax liabilities) will be the sole responsibility of the winner.

7 Acknowledgements

- 7.1 By entering into this Promotion, Entrants acknowledge and agree to:
- (1) these Conditions; and
 - (2) the Promoter's privacy policy (<https://www.stihl.com.au/en/legal-info/privacy-policy>);
- 7.2 To the maximum extent permitted by law, the Promoter is not responsible for any loss, damage or injury to Entrants resulting from their entering into or participating in this Promotion.
- 7.3 Any questions, comments or complaints regarding the Promotion should be directed to the Promoter.

8 Privacy and consent

- 8.1 Personal information including the Entrant's name, email address, telephone number and address may be collected and used for the purpose of conducting this Promotion. The Promoter may also disclose this information to third parties, including local regulatory authorities and the Promoter's agents or third-party service providers, for the purpose of conducting the Promotion, or for promotional and marketing purposes (including for direct marketing), whether during or after the Promotion (**Purpose**).
- 8.2 By entering this Promotion, the Entrant consents to the use of their personal information for the Purpose, and also that the Promoter may contact them for future promotional and marketing purposes without payment. Entrants agree that the Promoter may use this information for that purpose.

9 General Terms

- 9.1 To the maximum extent permitted by law, the Promoter reserves the right to vary the Conditions of, or cancel, the Promotion at any time without liability to any Entrant or other person (subject to compliance with applicable regulations and any directions of a licensing authority).
- 9.2 The Promoter shall not be liable and excludes all liability (including but not limited to negligence, infringement of third party intellectual property rights and misleading or deceptive conduct) for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) for damage to property, personal injury or death suffered or sustained in connection with the Promotion or the use or taking of any prize, except for any loss, damage or injury which is due to the negligence or wilful misconduct of the Promoter, which otherwise cannot be excluded by law.
- 9.3 All taxes (excluding goods and services tax), which may be payable as a consequence of a winner receiving a prize, are the sole responsibility of the winner.
- 9.4 These Conditions do not exclude or limit the application of any statutory provision (including a provision of the *Competition and Consumer Act 2010 (Cth)*), where to do so would contravene that statute.
- 9.5 In the event of a dispute concerning the conduct of the trade promotion or claiming a prize, Entrants must contact the Promoter to attempt to resolve the dispute in good faith. Any disputes will be addressed by the Promoter with the Entrant. If the dispute cannot be resolved, the Promoter's decision will be final. The Promoter must act reasonably and in accordance with these Conditions.
- 9.6 The laws of Australia shall govern these Conditions and the conduct of the Promotion.
- 9.7 The parties submit to the non-exclusive jurisdiction of the courts of Australia.
